## Government Affairs & ECPAC Donations The Dollar that Hollers

Let's face — no one wants to invest money in something that doesn't have a positive result associated with it. Warren Buffett didn't invest in *Geico* and *Coca-Cola* because he thought they were going to fail. Donald Trump doesn't invest in real estate in a geographical area that is not popular and established. It is the same feeling when a Contractor gives a donation to ECPAC (Electrical Construction Political Action Committee) on a yearly basis.

The question arises: "Where does my ECPAC donation go?" and "Did my donation have a positive effect in the political world?" This is a question that will always be in the minds of an ECPAC Contributor, for which there are only a few ways to answer.

It starts at the National NECA headquarters, specifically the Government Affairs department currently managed by Executive Director Lake Coulson and assisted by Kristen McDonough. Both have ongoing relationships with members of Congress – whether those members are Democrats or Republicans does not matter as long as they support the better needs of our industry. With that said, the political representatives who stick out the most by showing loyalty and cooperation are the ones that are under radar for counter-support, or contributions, from the Association. Breaking News

After experiencing a queasy hangover from the early November 2010 political buzz, there have been some satisfying results from the NECA Government Affairs office – particularly from a letter sent out from Mr. Coulson shortly after Election Day. In the letter, it was calculated that of 183 House candidates who received PAC contributions – 164 were elected, making the success rate 89.6%. At the Senate level, 21 out of 26 candidates who have gotten ECPAC contributions won in the general election, making that success rate 91.3% (excluding three occasions where both a Republican and a Democrat were given contributions).

To be even more critical, there are some ways to find who those contributions go to and where they're coming from. An online web source called Open Secrets (www.opensecrets.org) will allow you to find candidates that were selected to receive ECPAC donations in the past or the present, whether it was from two months, or two years ago.

In all, it is good news that much of the NECA-supportive candidates did get in office and it could be better news to see what they are capable of while in Washington or Springfield, respectively. One hundred of those candidates are brand new faces, which will hopefully widen the gap of possibilities and ambitions that we as NECA members are looking to succeed. Special thanks goes out to all the ECPAC contributors of 2010, the PLC Members, and to the efforts of the Government Affairs office in Bethesda, MD.

# **Bad times means increased Scrutiny**



It is not a secret that the suffering economic times are causing changes in people's personal lives, changes in government, and changes in higher authority. Whether you're a project manager, supervisor, company accountant, receptionist, or even an employer – the change that you may be encountering the most is the amount of scrutiny in your job performance. While company-specific budgets are being cut and employee positions are being consolidated - someone of a higher authority is overlooking the activity of that budget beyond the cuts and also paying more attention to an employee's day-today responsibilities. This is also true as an employer being studied by a customer, and in our industry – a contractor being scrutinized by many levels of authority like a general contractor, client or customer, OSHA, municipalities, Unions,

IRS, FDIC, and believe or not - by other contractors.

In 2010, OSHA began revealing information about changes made within their Enhanced Enforcement Program. Some changes were so drastic that they had to rename the program to the Severe Violator Enforcement Program (SVEP), which is on the radar for many employers around the country because it has a high probability of causing increased costs and scrutiny. According to the OSHA website (www.osha.gov), the SVEP will "include mandatory follow-up inspections, increased company/corporate awareness of OSHA enforcement... and federal court enforcement..." It is also noted that these changes are targeted for repeat offenders and non-compliant employers, which doesn't apply to many NECA members, but may affect them through increased penalties and tougher enforcement guidelines.

Large government organizations like the FDIC and the IRS have also modified or added some items to their examination structure. In 2009, the FDIC actually increased their budget to include funding to temporarily hire more "team examiners" in order to crack down on a number of banks – large and small. There was also news that the IRS was planning to hire thousands of new tax enforcement agents for increased scrutiny on businesses after the Health Care law was passed by Congress. This could potentially cause a level of increased scrutiny in areas other than just tax enforcement, and eventually lead to a jump in audits, examinations, and fines.

Scrutiny can also be viewed upon by local area affiliates as well. A general contractor or customer may be reviewing several parts of your business like labor, material, and change-order costs. Because of the power of the web - the ability to access resources, like material costs, can be detrimental to an employer's profit. Additionally, municipalities are finding ways to increase their workload by enforcing inspector authority and focusing more on local code requirements, which may or may not place a burden on contractors. Not to mention that because of the lack of electrical construction overall - Unions and their agents are making more frequent visits and paying more attention to the little work that's being performed.

Another unfortunate result of the declining times is the act of turning on each other.
